- Knowledge of and ability to follow and apply the policies and procedures of the White Earth Tribal Council.
- Ability to interact therapeutically and positively with troubled youth and families.
- Skills in computer operations and document development.

Qualifications:

- BS/BA in related field AND 1-year supervisory experience OR AA in related field and two (2) year related experience including 1 year supervisory experience OR HS diploma/GED and three (3) years related experience/education INCLUDING 1 year supervisory experience.
- Experience in a residential/chemical dependency treatment setting preferred
- Experience in crisis prevention and intervention preferred
- CPR certified or willing to obtain upon hire.
- Must be over age 18, responsible, mature, healthy adult who is able to carry out the duties assigned.
- Must be free of chemical use problems for at least 2 years immediately preceding their hiring and must sign a statement attesting to that fact and freedom from chemical use problems must be maintained during employment.
- Must pass a Background and Drug Screening.
- Valid driver's license and insurance for travel between sites and other business-related destinations.
