- Maintains General Files, Client Files, and/or Program Files to ensure compliance with department policies and procedures.

- Knowledge of the White Earth Reservation demographics, culture, history, and lifestyles.
- Skill in operating a variety of weapons, equipment, and motorized vehicles.
- Skilled in customer service and the ability to interact with internal and external customers with tact and diplomacy.
- Ability to comprehend intricacies of law, codes, regulations, manuals, and technical materials.
- Ability to work harmoniously with individuals, community groups and the judicial system.
- Ability to be certified in First Aid/CPR/AED through the American Medical Association
- Ability to assess situations and make independent, sound decisions.
- Ability to identify fur bearings, game animals, waterfowl, plants, flowers, endangered species, fish, habitats, and all wildlife.
