The White Earth Reservation Business Committee is currently seeking a qualified applicant who will be responsible for providing comprehensive nursing services to women and their families eligible for the NFP Program. Responsible for maintaining the highest standards in clinical nursing practice and adherence to the NFP model policies, procedures, guidelines, and standards of NFP and White Earth Health Division. Provides for the preventative, therapeutic and restorative aspects of nursing care based on systematic assessment of client, family and community needs and public health services.

Position Outcomes:

- Develops therapeutic relationships, utilizes concepts of reflection and motivational interviewing with families in a home visiting environment.
- Assesses physical, emotional, social, and environmental needs of families in a home visiting environment.
- Provides case management and care coordination for high-risk individuals, family, or community situations.
- Evaluates effectiveness of plan and makes changes as necessary.
- Documents assessment and intervention data in medical record.
- Participates as a member of a multidisciplinary team to facilitate improved outcomes.
- Maintains professional competency by pursuing continuing education opportunities.
- Provides training, orientation, and education to staff, students, and other health and human services professionals in the community regarding public health practices.
- Performs other duties and responsibilities as required or assigned.
